#### July 24, 2009 Coordinators Report

At present we have 25 active client files. Some files consist of families so may have more than one client per family. At present we are doing crisis management and some prevention work with the families. Ann is very busy with her clients. She has 6 clients that should be under the PCAP program.

Insurance for Staff (WCB, Benifits, Program) are being worked on and finalized.

Diane Malbin's program "Pebbles" will be offered out of our office via workshop style. This program is FASD 101 that can be adapted depending on the audience. This program will be used to train staff as well. We are the first agency to offer this, so we need to keep data on the workshop (satisfaction, relevancy, follow-up, community focus, etc). Diane will be kept informed of each presentation.

Equipment donations were received from Brighter Futures for children with disabilities. This equipment was forwarded on to the physio and occupational therapy department at the hospital in High Level who were happy to receive it.

I met with Dorothy Henneveld with Catholic Social Services FASD Programs in Edmonton for 2 days in July. This was to get an idea of the structure of the programs that they offer and how we can utilitze their knowledge in developing our programs. We have been paired with the FASD Programs in Edmonton as mentees. I also sat in on the McDanial Youth Mentoring Program for youth with FASD meeting. This was very informative.

We are getting more organized at the office and do as much as we can between client/case work.

Using the Camp Funding, two persons were hired o work with the Day Program for children at FCSS. There are 4 individuals registered who have one of the FASD Diagnosis. This has been a bonus for the program, families and children in providing support all around. This program will go until August 28.

### **Clinic Report:**

**Youth Clinic**: At present the PCN FASD Clinic has 30 open files with 5 pediatire cases that will be referred to Glenrose FASD clinic. The next youth clinic will be on August 25. Funding is being looked at so that we know the number of clinics we can hold to the end of March, 2009. Cost recovery procedures are being discussed with those agencies referring clients for clinic. There s a new nurse for the Diabetes Program at PCN. There has been a question as to whether diagnosis need to be updated at certain times.

**Adult Clinic**: At present we have 5 adults who will be going through Clinic on August 27 and 28. The clinic will take place in Chateh with some members of the team being from the community of Chateh. Colleen Burns is coordinating the Adult clinic. The Health Program at Chateh will be covering the clinic costs for the doctor and the neuro psychologist.
